A WORD FROM SARAH



Dear Friend,

This year has been one of tremendous growth for Kids FIRST. When you're an organization that provides child abuse intervention services, growth can sound like a bad thing—like there are more kids in need of our services. But it isn't just that. While the number of kids we're serving has grown overtime, our team has remained small (but mighty!) with about 50% of the staffing of comparable Children's Advocacy Centers. This year we **doubled** the size of our team. We didn't expand to serve more children, though. We expanded our team to serve children and families better.

Since 2016, we've had one full time physician, Dr. Deanna St. Germain, DO, to provide child abuse medical assessments for children in Lane County. We served over 800 children this year—one provider simply cannot meet the need. So, we hired Dr. Lauren Awe, DNP, to join our medical team. Now all children we see for forensic interviews can also be seen by a medical provider during the same appointment. Since Dr. Awe joined our team, we've been able to double the number of children receiving medical assessments!

The need for mental health services in Lane County is significant; high demand and a lack of providers often leave children facing waitlists for several months before receiving treatment. But their needs are acute—they simply can't wait. To address this crisis, Kids FIRST took a tremendous step this year: we hired therapist Becky Austin, LCSW, to launch an onsite Therapy Program for the children and families we serve. Evidence-based mental health screenings are now a part of our comprehensive child abuse assessments so that mental health concerns can be identified and children and youth can receive the therapy needed to heal and thrive.

At Kids FIRST, the health, safety and well-being of children is our top priority so this investment in expanded programming was a no brainer. We also hired several new advocates, a medical assistant, a bilingual forensic interviewer, and a clinic manager. We now have 22 incredible staff members who each have a role to play in helping children heal. We're incredibly proud to offer expanded services to children and families, and at no cost to them. You, our community of supporters, have made this possible. As you review this report, take pride in your investment and the difference you've made.






