KF PROVIDES INTERVENTION AND ADVOCACY TO BETWEEN 600-700 CHILDREN AND THEIR FAMILIES EACH YEAR FOR CONCERNS OF SEXUAL ABUSE, PHYSICAL ABUSE, WITNESS TO DOMESTIC VIOLENCE OR OTHER CRIMES. CHILD ABUSE ASSESSMENTS INCLUDE FORENSIC MEDICAL EVALUATIONS, CHILD FORENSIC INTERVIEWS, VICTIM ADVOCACY AND CRIMINAL JUSTICE SUPPORT, AS WELL AS THERAPY SERVICES AND GRAND JURY HEARINGS ONSITE.
